REPRESENTATIONS

Professional Liability

Won a unanimous Colorado Supreme Court opinion strongly upholding Colorado's strict privity rule in determining whether non-client beneficiaries may sue an estate lawyer for malpractice or professional liability. The Court adopted the most stringent test, as WTO advocated.

Prevailed before the Tenth Circuit Bankruptcy Appellate Panel, which affirmed a bankruptcy court's order of summary judgment for WTO's law firm client.

Obtained dismissal of a RICO claim brought against a national law firm and which exposed the client to treble damages.

Won a complete defense verdict in Wyoming for a \$19 million medical negligence lawsuit brought by a plaintiff who suffered a stroke following ER treatment for a head wound.

Won a complete defense jury verdict in Ohio for an obstetrician facing damages claims in excess of \$15 million. WTO's client died tragically and unexpectedly a month before trial, compounding our challenge to defend the care.

Won a complete defense jury verdict in California for an ER doctor facing over \$22 million in damages claims. WTO was called in just 10 days prior to the three-week trial. Seven other defendants settled, but WTO successfully defended our client on the facts.

Won a complete defense jury verdict for a spinal surgeon in a multimillion-dollar Colorado lawsuit. WTO effectively demonstrated that our client was not at fault for the patient's partial paralysis.

Won a complete defense jury verdict in a \$31 million medical malpractice lawsuit in Illinois involving a newborn who contracted meningitis.

Won a complete defense jury verdict in Ohio in a two-week, \$18 million trial involving alleged birth injuries. WTO lawyers were hired just three weeks before trial.

Product Liability

Won a complete defense jury verdict for an infant car seat manufacturer in a \$15 million federal failure-to-warn trial. This was the retrial of one claim from a 2012 case that WTO won.

Won a unanimous defense verdict for a major tire manufacturer following a three-week trial in Arizona state court. The plaintiff demanded \$20 million in actual and punitive damages. Our client was found not at fault on all claims.

Won reversal of a 2013 jury verdict against a major carmaker in a case that alleged strict liability and negligence relating

to a rear-end collision. The Court of Appeals concluded that the application of consumer expectation as a standalone test in Colorado's pattern jury instructions does not comply with Colorado law as established by the Colorado Supreme Court in *Camacho v. Honda Motor Co.* (1987).

Contributed to a summary judgment win for a leading pharmaceutical company in an antidepressant birth defect case in Philadelphia. WTO lawyers cross-examined the plaintiffs' only expert to offer live testimony, leading to the exclusion of both of the plaintiffs' experts.

Commercial

Won a complete defense decision for a leading automaker in a five-year, \$50 million lawsuit culminating in a month-long trial in California Superior Court.

Won remand from the Colorado Court of Appeals, vacating the district court's order finding WTO's client in contempt of a settlement agreement. The ruling undid the district court's finding of \$10,000/day sanctions allegedly accruing against our

Won a Fifth Circuit appeal upholding a trial court's summary judgment for a tiremaker in a case alleging conspiracy to prevent the plaintiff from obtaining the company's racing tires for use in the American Le Mans racing series.

Won summary judgment on fraud and *quantum meruit* claims asserted against clients in a shareholder dispute.

Representing multiple defendants in a \$1.2 billion federal antitrust class action.

Representing one of the nation's largest healthcare franchisors in a federal court action challenging the legality of the underlying business model.

Won summary judgment for a national hotel franchisor in a case alleging premises liability injury to a guest.

Defending a Fortune 200 food producer in litigation arising out of a massive plant explosion. Plaintiffs have claimed more than \$100 million in damages.

Trade Secrets & Intellectual Property

Won a directed verdict in a trade secrets trial for an oil and gas company. The plaintiff claimed theft of its technical geological data had caused more than \$1 billion in damages.

Obtained a temporary restraining order stopping the Telluride Film Festival from screening a hotly contested documentary. The federal injunction protected the name and image rights of one of the most renowned soul singers of all time. WTO was hired just 25 hours before the screening was to occur.

Assisted a biotech company before the Federal Circuit, resulting in reversal of an adverse summary judgment and remand to the state court where our client had filed the complaint.

Insurance

Successfully represented seven codefendants in a massive property insurance class action lawsuit in Colorado. Plaintiffs claimed they were systematically underinsured in a "monumental" conspiracy, in violation of federal RICO and antitrust laws, involving virtually all property insurers in Colorado as well as industry trade groups. WTO served as liaison committee counsel, and the joint defense group ultimately won its motion to dismiss.



Won reversal from the Colorado Supreme Court for a leading nationwide insurance company in a precedent-setting ruling on the practice of "assigning" potential future personal injury settlements to third parties, such as medical lien companies.

Successfully defended a leading nationwide insurer in an insurance bad faith and breach of contract trial arising out of a devastating Colorado wildfire in 2012. The plaintiff voluntarily dismissed one claim the morning of trial, lost another, and was awarded just five figures on the third after having demanded more than \$1 million.

Obtained summary judgment in a putative federal class action, eliminating claims brought for alleged bad faith and Colorado Consumer Protection Act violations. The remaining contract claims are pending.

Representing major national insurers in class action litigation in Montana and Washington.

Class Action

Won a precedential Third Circuit opinion for a luxury carmaker, vacating a district court's order to certify classes in six states to pursue claims that sunroofs in all models manufactured from 2003 to the present are defective.

Defending a Fortune 10 company in all litigation, including class actions, arising out of a catastrophic sixalarm warehouse fire that led the government to issue a shelter-in-place advisory while the fire burned.

Negotiated dismissal from high-stakes Canadian class action litigation for an oil and gas company involved in the deadliest train derailment in Canada since the 1800s. WTO attorneys conducted litigation in English and French to negotiate our client's exit.

Defeated class certification in a complex oil and gas royalty dispute involving employee rights dating back to original North Sea asset discoveries.

Obtained voluntary dismissal of the final two surviving claims in toxic tort class action litigation in Ohio for a major appliance manufacturer. WTO won dismissal in 2014 of 15 of 17 claims.

Won dismissal of class action litigation in California for a maker of high-end wall ovens.

Defeated class certification for a leading oil and gas producer in a natural gas royalties underpayment case heard in federal court in Wyoming.

Successfully opposed plaintiffs' *certiorari* petition to the Colorado Supreme Court, leaving in place a Court of Appeals ruling for our client and eliminating a \$750 million exposure threat in alleged moratory interest in an oil and gas royalties class action lawsuit.

2015 HIGHLIGHTS

Denver Public Schools Foundation champions public education to help every child succeed. Partnering with a Denver public elementary school, WTOF provided 11 volunteer tutors who virtually tutor first-graders in literacy.

The Gathering Place is Denver's only daytime shelter for women, children, and transgender individuals experiencing homelessness and poverty. WTO volunteers cooked and served hot breakfasts to more than 100 women and children on three separate mornings in the past year. One woman made a point of saying, "Thanks for serving us breakfast. It's a kind gesture that makes us feel normal as we struggle to get back on our feet."

Metro CareRing operates one of the largest food pantries in Denver. WTO raised \$16,206 in cash and nonperishable food items in the Denver Bar Association's annual citywide law firm donation drive.

Movember Foundation raises funds to treat and prevent prostate cancer. WTO personnel donned mustaches to raise awareness and money at our fourth annual Movember mustache fundraiser. WTO raised \$420 for the Movember Foundation.

Denver Kids, Inc. offers one-to-one counseling and mentoring to help at-risk K-12 Denver Public School students graduate from high school. WTOF raised \$4,600 and three boxes of schools supplies to donate.

Peach's Neet Feet paints and distributes personalized shoes to children who have experienced hardship in the form of chronic illness and disability. WTO lawyers and staff raised \$4,850 for Peach's Neet Feet.

Rocky Mountain Dawgs Project was established in honor of Cpl. David Michael Sonka, a son of one of WTO's staff, and his multi-purpose canine, both of whom were killed in action in Afghanistan. WTOF raised \$2,320.
