## CASES

A 12-member jury unanimously rejected the plaintiff's claims, agreeing that WTO's client had acted in good faith. WTO also won the Tenth Circuit appeal.

- Won an arbitration involving a \$50 million claim brought by a joint venture partner against WTO's oil and gas company client.
