## CASES

### Commercial Litigation

- Won a \$3.4 million jury verdict, resulting in a \$5 million final judgment that was fully recovered by a family office that was the victim of a cyberattack.
- Won affirmative summary judgment for a Canadian company in a dispute to recognize a \$9 million breach-of-contract judgment entered in Alberta, Canada. WTO lawyers persuaded a Colorado federal court to recognize the judgment without an evidentiary hearing under the Uniform Foreign Country Money Judgments Recognition Act.
- Recovered breach-of-contract damages for a healthcare business services provider in arbitration against its former client that is one of the nation's preeminent hospital systems.
- Won a \$14.3 million arbitration award, plus attorneys' fees and costs, for a multistate cannabis operator in a Florida franchise dispute involving lost royalties and right-of-first-refusal issues.
- Successfully represented a Fortune 100 chemical company in a post-divestiture transaction dispute against a foreign government-owned investment company. WTO recovered tens of millions of dollars in cash plus non-cash value and helped secure closure of an antitrust inquiry.

## Class Actions

- Defeated certification of a putative class of 20,000 California claimants alleging that WTO's client was a "joint employer" and was liable for unpaid overtime and other wage-and-hour violations.
- Won final approval of class settlement and *vacatur* of a \$15 million attorneys' fee award from the Ninth Circuit in a consumer class action for Whirlpool.
- Successfully represented a major telecommunications company in an MDL involving 18 underlying consumer, securities, and derivative class actions that challenged the company's marketing and sales practices.
- Defeated class certification for Electrolux in a consolidated putative class action in Illinois involving millions of the company's dishwashers.
- Defeated class certification in a bellwether case alleging false advertising of innovative self-cleaning ovens. The plaintiffs sought certification of a six-state class in the lead case and filed related actions for consumers in many other states. The court's certification ruling paved the way for a non-class settlement and dismissal of all actions less than a month before the first trial.
- Won unanimous Seventh Circuit victory in a fee dispute for Whirlpool and Sears arising out of a certified federal class action lawsuit that WTO favorably settled after winning a defense verdict in the bellwether trial of related claims.
- Won a motion to dismiss with prejudice a putative class action in federal court in California. The plaintiff alleged violations of the Federal Fair Debt Collection Practices Act (FDCPA) and California's Rosenthal Fair Debt Collections Practices Act.

# MICHAEL T. WILLIAMS

- Successfully represented a Fortune 20 company in class action and insurance litigation arising from a six-alarm warehouse fire. WTO's client paid just 1% of claims—which it then recovered through affirmative claims against other parties and their insurers.
- Won a complete defense jury verdict for Whirlpool as co-trial counsel in a \$66 million certified class action trial in Ohio involving allegedly "moldy" washing machines.
- Obtained dismissal of class action allegations and 15 of 17 claims against Whirlpool in an environmental toxic tort case. Plaintiffs voluntarily dismissed their remaining claims after the court's ruling.
- Successfully negotiated a class settlement for Pilot Flying J as national resolution counsel in diesel rebate litigation.
- Defeated a motion to certify a nationwide breach of warranty class in a case alleging that certain Kenmore washing machines contained defective electronic control boards that caused the machines to malfunction.
- Defeated certification of a multistate class action in Arkansas federal court involving claims that certain Whirlpool-made refrigerators were defective.
- Successfully defended a large Colorado automobile dealer in a consumer class action in which the plaintiffs alleged violations of the federal Telephone Consumer Protection Act and sought hundreds of millions of dollars in damages. The trial court denied class certification, and the Colorado Court of Appeals affirmed that order on appeal, and the Colorado and U.S. Supreme Courts denied certiorari.
- Successfully defended a Colorado software company in a securities class action in which the client asked WTO to replace an international law firm as lead trial counsel 90 days before trial.

## Energy

- Successfully represented an oil and gas exploration company in a suit to compel specific performance of a lease purchase agreement that a counter-party breached during the pandemic.
- Successfully represented an oil and gas exploration company to recover damages from a non-operating working interest owner for failure to pay its share of well drilling and completion costs during the pandemic.
