## CASES

- Secured a zero-dollar walkaway settlement from a plaintiff in Boulder County who demanded \$10 million in a civil case following a high-profile alleged criminal assault.
- Won the first medical malpractice defense verdict in plaintiff-friendly Las Vegas, New Mexico in over 35 years for a hospital in a \$40 million case involving allegations of failure to diagnose and treat a lung disease which resulted in a patient's death. The jury unanimously found for WTO's client.
- Won exclusion of the plaintiff's causation expert and achieved summary judgment in a medical malpractice case. The victory also led to an award of more than \$40,000 in attorney fees.
- Won summary judgment for a correctional healthcare provider and nurse in a medical malpractice case involving endocarditis.
- Achieved exoneration for an oncologist facing sexual assault allegations in Indiana. After a two-year investigation, the State of Indiana determined that the allegations were unfounded and announced that it was dropping the case.
- Achieved a complete defense victory for a hospital client and staff by negotiating dismissal with prejudice—with no money paid—of a lawsuit in Colorado state court. The case involved highly sensitive criminal and civil claims of post-surgery sexual assault.
- Won a defense verdict in federal court for a hospital and its staff against \$27 million malpractice and negligence claims involving a subdural empyema.
- Represented a New Mexico hospital in 12 cases involving criminal conduct allegations against a psychiatrist.
- Conducted an internal investigation of a hospital employee accused of sexually assaulting two patients in the recovery room following surgery.

- Represented a psychiatric facility in Georgia in a wrongful death case involving a patient who murdered two family members after being discharged.
- Served as monitoring counsel to an insurance company in nine cases in California involving claims of sexual abuse against a physician.
- Defended an Oregon clinic and multiple healthcare providers against claims of sexual assault alleged to have occurred during an out-patient procedure.
- Won a unanimous defense verdict in a \$55 million trial in eastern Kentucky for a hospital accused of malpractice.
- Won a complete defense jury verdict for a mental health hospital in Virginia. The plaintiff claimed \$32 million in damages arising from an alleged patient-on-patient sexual assault.
- Won a complete defense jury verdict in California for an emergency room doctor in a medical malpractice lawsuit with over \$22 million at stake in damages claims. WTO was called in just 10 days prior to the three-week trial.
- Served as national counsel to a global healthcare company in multidistrict litigation involving over 12,000 claims relating to dialysis products. WTO helped develop national resolution strategy, identified bellwether cases, and negotiated settlement of all claims.
- Obtained dismissal of class action allegations and 15 of 17 claims against Whirlpool in an environmental toxic tort case. Plaintiffs voluntarily dismissed their remaining claims after the court's ruling.
