- Substantially prevailed at trial for a national franchisor in a more than \$50 million case brought by franchisees alleging numerous express and implied breaches of the franchise agreements and seeking related declaratory judgments.
- Following a multiday evidentiary hearing, secured injunctive relief for a franchisor against businesses that were unlawfully competing against it using franchisor's trade secrets, including client information, and infringing on franchisor's trademarks.
- Won a complete victory following a four-day arbitration for the nation's leading beauty and wellness franchisor, which was accused of fraud, franchise disclosure violations, violations of unfair competition laws, and breach of contract. WTO also successfully countersued for breach of contract and trade secret misappropriation, obtained preliminary and permanent injunctions, recovered liquidated damages, and secured an award of attorneys' fees and costs.
- Won a directed verdict on a Colorado Wage Claim Act claim and secured voluntary dismissal of defamation and punitive damages claims for a large regional bank the night before closing arguments in a five-day trial after four-plus years of litigation.
