- Called in two weeks before trial, won a defense verdict in a multimillion-dollar medical negligence trial in Utah for an orthopedic surgeon and physician's assistant accused of allowing a patient to slide off the operating table, allegedly leading to permanent brain and spine injuries. WTO demonstrated that the plaintiff's complaints were actually due to prescription drug overuse and that the plaintiff had lied under oath.
- Won a *Frye-Mack* hearing to exclude expert testimony and Cranial Compression Ischemic Encephalopathy (CCIE) causation theory in a Minnesota birth injury case involving issues of first impression. The resulting order will help defense attorneys nationwide against CCIE claims.
- Successfully represented a major nationwide health system as second chair in a negligence jury trial involving alleged patient-on-patient sexual assault in a mental health facility. The case settled favorably after close of the evidence and prior to closing statements.
- Defending a Washington state hospital in a high-exposure case involving the care and treatment of a stroke patient.
- Represented a franchisor of more than 350 restaurants in its premises liability litigation, favorably settling numerous cases for the client.
