REPRESENTATIVE CASES

Wondering what you might handle at WTO? The following highlights are just a taste of the sophisticated, high-stakes, and high-profile cases WTO lawyers are leading every day.

COMPLEX COMMERCIAL

- After four years of litigation and just two months before trial, WTO helped resolve a \$2.1 billion federal antitrust and labor class action challenging the au pair exchange program administered by the Department of State. As a result, the defendants paid only 3% of the demand and the program continues unchanged.
- Successfully represented Aimco, one of the largest apartment owners in the U.S., in nationwide litigation alleging intentional torts against Airbnb. After jury selection in the first trial, Airbnb settled all litigation on terms allowing Aimco to control short-term rental activity consistent with its contract and property rights.
- Won a rare, permanent injunction against a major distributor that infringed on WTO's client's exclusive distribution territory. The lawsuit involved bet-the-company stakes and is having multibillion-dollar repercussions in the industry.





PRODUCT LIABILITY & MASS TORTS

- Representing Whirlpool in all consumer class action defense nationwide.
- Won a complete defense jury verdict for Michelin in a nine-week trial in Florida with \$80 million to \$1.2 billion at stake, and won the ensuing appeal.
- As lead national trial counsel to GE Healthcare, defeated plaintiffs' attempt before the U.S. Judicial Panel on Multidistrict Litigation to create an MDL involving gadolinium-based contrast agents.

PROFESSIONAL LIABILITY

- Won a landmark federal case in Illinois defining for the first time the roles and obligations of lead and liaison counsel in multidistrict litigation.
- Won a defense verdict for a physician in a four-week trial with \$70 million at stake in a case involving bacterial meningitis in a minor.
- Argued and won a motion to dismiss \$150 million malpractice claims brought in Nevada against an AmLaw 200 firm. The allegations involved the accuracy of an underlying tax opinion.

APPEALS

- Argued and won for FCA (fka Chrysler) before the Sixth Circuit in a case involving the question of whether federal legislation preempted Ohio state dealer laws.
- Argued and won for a leading U.S. railroad operator before the Tenth Circuit to uphold the dismissal of claims brought by a third-party intervenor.
- Argued and won for Michelin before the Second Circuit to uphold WTO's summary judgment victory in a fraud case in the Southern District of New York.

INSURANCE

- Won two landmark, Tenth Circuit rulings regarding property damage appraisals and defeating fraudulent appraisals and corrupt appraisal practices.
- Won a groundbreaking ruling from the Colorado Supreme Court requiring insurance appraisers to be fully unbiased and impartial.
- Won an "extraordinary remedy" for State Farm in the Colorado Supreme Court relating to attorney-client privilege.

EMPLOYMENT

- Enforced a noncompete agreement in federal court against a former executive seeking to launch a competing firm by taking 50 clients representing \$200 million in investments.
